Tree removal applications are only required for protected trees that are greater than 20cm diameter breast height (dbh), however, if you require an application to remove trees greater than 20cm dbh you will need to provide us details on those less than 20cm dbh to allow us to accurately calculate fees.

  - Location of adjacent trees (if applicable)
- For trees in imminent failure, or for dead, dying, diseased or damaged beyond expectations of recovery, photographic evidence of the tree's condition
- For trees that are deemed inappropriate for their size, species or location, an Arborist report

- Nesting bird survey (if applicable)
- Agent authorization form (if applicable)

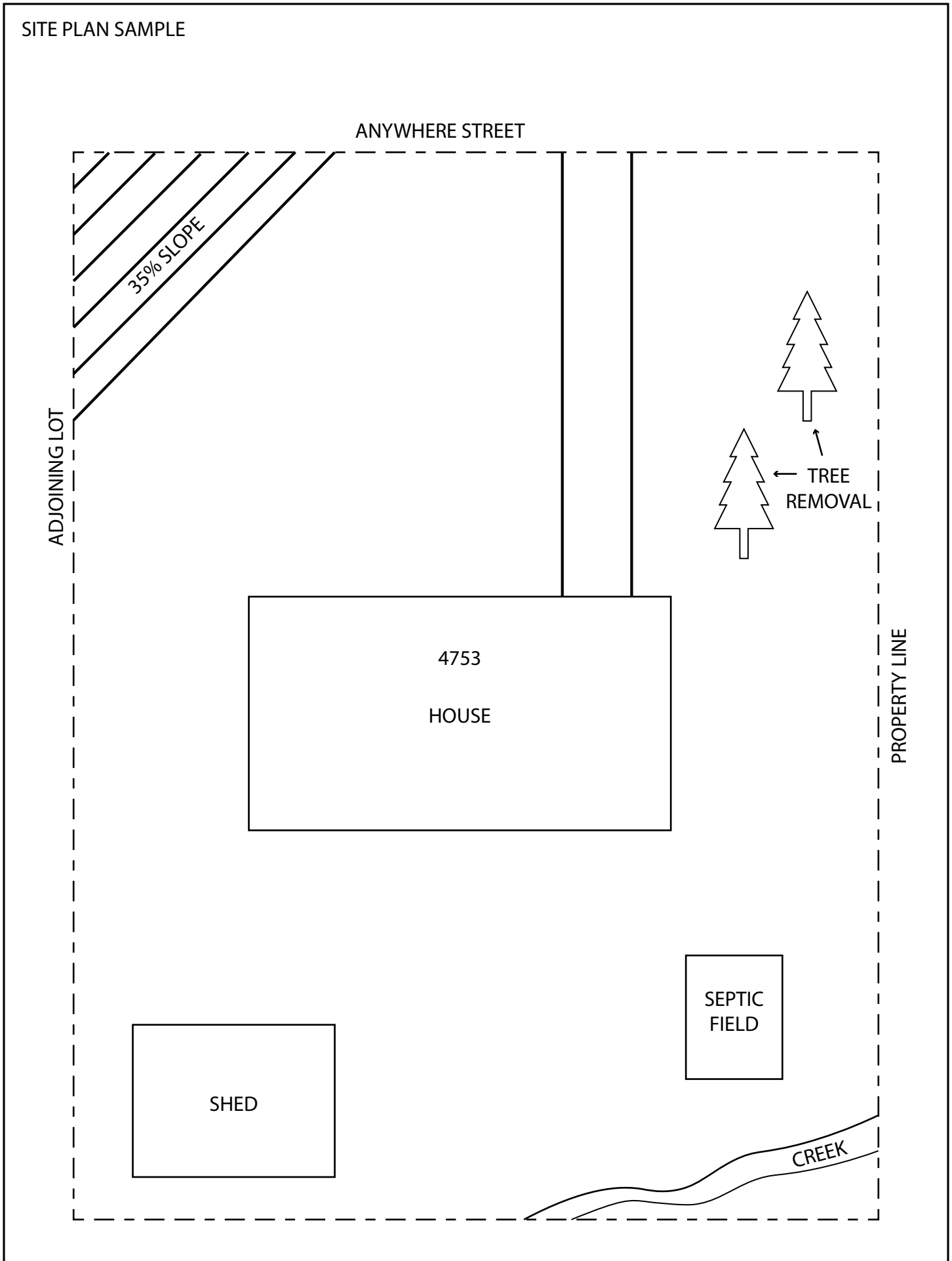
